2.) State of Affairs (Staff to Board)

8:10 - 8:25

- Bend Oktoberfest Mindy reported that she had received a few inquires about why Fall Fest had happened, but not Oktoberfest. She checked-in with all of the directors to make sure they understood the difference between these events and why this choice was made. There were no questions from the BOD.
- Holiday decorating & community programming *Mindy reported* that staff was excited to announce some big wins in this area
 - Staff had worked with Lowes to get a substantial discount on ALL new wreaths for downtown
 - Staff had purchased lights for every lamppost in the downtown district, and the plan was to wrap all of the posts
 - Staff was working on new 'Welcome Winter' banner designs for all double banner posts.
- Loss of staff/New Hire Mindy reported that Hayden decided to leave the DBBA and that they were hiring for a new staff member to take over that position.
- New banner website Mindy reported that she had designed the banner program to be scheduled through an automated system on their website, which would save hundreds of staff ours every year. She explained how increasing efficiencies like this, as well as increasing the budget, would be necessary to get to the future vision that everyone held for the DBBA and Downtown Bend.

- Business Contribution to Downtown's Holiday look & feel Window Displays & Holiday décor. Several directors requested that the DBBA encourage business & building owners to decorate for the holidays. They discussed a map for folks to look at windows after the tree lighting, maybe a contest where someone could win downtown dollars, Christine suggested the hashtag #winterwindowland
- New Hire send possible candidates to the DBBA
- Shared photo album/forum for downtowners? Directors discussed the need for a way that business owners could communicate with each other. Christine suggested a shared photo album so that people could upload pictures from their phone to share with other downtowners.
- Kindness Campaign Directors discussed the need to communicate with our community and visitors to Be Kind in downtown. We discussed ways to encourage this including the option of offering banner clients a discount on display if they put this at the bottom of their banners.
- Conflict Training for downtown staff In concert with the above discussion, directors discussed the need for employees to have additional training in deescalating conflict.
- Business Banners A director suggested that we offer businesses the chance to have a banner reflecting their business and that we do a campaign where we celebrate local with banners in downtown.
